Special Education teachers receive a thorough knowledge of evidence-based technologies for identifying, instructing, and assessing students with special needs including Introduction to Conditions, Learning & Behavioral Disorders, Applied Behavioral Analysis, and Methods for High and Low Incidence conditions. Special Education candidates also have 2 courses specific to teaching mathematics, 2 courses specific to teaching reading, and 1 course specific to Assessment including practice giving and analyzing the KTEA. General Education candidates receive 9 credits of Special Education instruction including an Introduction to Conditions, Differentiated Instruction, and Methods for teaching in an inclusive classroom. All candidates, regardless of major, take a 3 credit course in English Language Learner instruction. Urban school training is received through a course in Multicultural Education and through field experiences that are open to the candidates. Further education on ELL and diverse populations comes through our C3 initiative. This effort is a collaboration with International Programs office and connects candidates with actual ELLs in other countries such as Spain, Morocco, and Korea among others. Candidates used strategies learned in the course to aid students in non-English speaking countries to



converse and learn content in English. Additional diverse experiences are obtained through our Early Childhood Residency program, our partnerships with our region schools (almost all of which are considered High Need and Low SES), and a developing Urban experience with schools in Pittsburgh. The institution assures that candidates are prepared according to the needs of LEAs through collecting evidence, feedback, and data from the related entities through employer surveys, alumni surveys, and student teacher surveys as well as through advisory boards constituted with administrators from regional school districts.

All faculty model the use of integrated technology with their D2L course sites. Students access course content, submit documents, take quizzes, participate in online discussions, and monitor their course grade through this technology. In many of the methods courses, faculty assign technology integration components in the content area lesson planning. The Electronic Portfolio Assessment has been integrated into all technology courses to assess students' ability to meet the ISTE standards. Students prepare during their student teaching a Teacher Candidate Work Sample that documents their ability to collect and analyze data to improve student achievement and react to the data to adjust their teaching. All components of the teacher preparation program complete annual assessment cycle reviews to collect, analyze, and determine if follow-up actions are needed to strengthen the program. New insights into teaching via technology have been gained through the adjustments made during the pandemic. Parts of student teaching and the other field experiences were conducted virtually via teleconferencing and other web applications. Videos, case studies, and interactive experiences were all used to complete the clinical experiences. We have now also been able to add more realistic virtual experiences through the use of Mursion, an avatar based, interactive

virtual classroom experience. The curriculum will be adjusted to include more of these experiences intentionally to prepare students to teach remotely if necessary.

Students are encouraged to participate on IEP teams during field and student teaching experiences as allowed by the mentor teacher and partnering LEA. Special Education teachers are prepared according to PA state guidelines as well as in programs accredited by CAEP and IDA. With a focus on Direct Instruction and Applied Behavior Analysis, each student is required to take courses in Conditions including LD and BD, ABA, Assessment, Reading methods, Math methods, (both specific to students with disabilities), High Incidence and Low Incidence methods, along with a range of field experiences.

Special Education students learn about and are required to develop an IEP during their program. Students are also required to participate in IEP meetings and employ IEPs in their classrooms during field experiences and student teaching
