



## Summer 2023 Housing Application Reinhard Villages

**APPLICATION DEADLINE April 28, 2023**

**This application is exclusively for residents who currently reside in Reinhard Villages this spring 2023 semester and will be living in the same apartment in Reinhard for the fall 2023. If the resident is switching apartments within Reinhard for fall 2023, they must complete the regular summer housing application for summer school students. You MUST be registered for Fall 2023 classes to be eligible for Summer housing.**

\*Please be aware that maintenance, our cleaning vendor, and various other facilities related work will be done in all the apartments this summer. We will try to keep the interruptions to a minimum but they will occur.

\*The Reinhard Community Center Office will not always be open. Hours will not be standardized and will depend staffing.

\*Mail and package service will not be guaranteed over the summer. If you are dependent on your mail and packages being delivered you should get a post office box for the summer.

**Initial to confirm you understand the following expectations to have summer housing at Reinhard Villages. Failure to meet these expectations may result in loss of summer housing:**

\_\_\_\_\_ My student account is in good financial standing with the University and there is no outstanding balance.

\_\_\_\_\_ I will be registered for Fall 2023 classes by the last day of the Spring semester.

\_\_\_\_\_ If I drop my fall 2023 schedule, I agree to move out of my summer housing apartment within 24 hours of the dropped schedule.

\_\_\_\_\_ If I am on judicial probation, I have to be scheduled for in person summer classes to reside at Reinhard for the summer.

\_\_\_\_\_ If I am on academic suspension at the end of the Spring 2023 semester, I understand I will not be able to stay for summer 2023 housing. If I appeal the suspension, and the appeal is denied, I will have 24 hours to move out. If I do not appeal, I will have 24 hours to move out after the deadline to appeal academic suspensions has passed.

Students must live in the same apartment and bedroom for Fall 2023 that they do for Spring 2023 in order to sign up for Summer Housing. If the resident is switching apartments within Reinhard for Fall 2023, the student must complete the regular summer student housing application. Please initial below:

\_\_\_\_\_ I will be living in my apartment over the summer. I agree to the cost of \$800 that will be added to my student account in May 2023.

- You will be able to stay throughout the summer and have key access to your apartment.
- We will try to contact you in the summer notifying you when the cleaning staff will be in to clean empty bedrooms and your common areas.
- ALL personal items will need to be removed from common areas during your assigned cleaning time, so they can be cleaned. Items that are not removed, the cleaning service will move them and you are responsible for any additional charges.
- Your apartment will be checked the week of July 24 to ensure the common areas are clean and ready for the residents moving in for the Fall 2023 semester.
- If the apartment common areas are found not to be clean, the cleaning service will return to clean your apartment at your expense.

Please list any special housing accommodations approved by the Office of Disability Support Services.

Clarion University must review your criminal history to determine if you are eligible to obtain a housing contract. Depending on your criminal history, review can take from one to six weeks to complete. A representative will contact you if necessary.

Please answer the following questions. Please note that failure to provide this information may result in a delay or denial of your housing application. At this time, you do not need to provide additional information. If additional information is needed, *Residence Life Services* will contact you.
