Scholarships for International Students

1) Merit Scholarships

Freshman international students are eligible for merit scholarships; and eligibility is determined through the admissions process; applications are reviewed by the Director of Admissions. To be considered for a merit scholarship you must first complete the international undergraduate student application:

2) International Transfer Students

New international transfer students with a cumulative 3.0 or greater GPA are eligible to receive a renewable scholarship provided full-time enrollment is maintained, and the student is transferring in 12 or more credits from an accredited institution. Eligibility is determined through the admissions process; applications are reviewed by the Director of Admissions. To be considered for a transfer scholarship you must first complete the international transfer student application:

3) Panos & Pavlos Award

The Panos & Pavlos Award was established by Mr. Panos Theodoridis (1990) and Mr. Pavlos Ignatiades (1986, 1998) **for Cypriot or Greek international students.** For consideration, please contact the Office of International Programs if you qualify for this scholarship as an international student from Cyprus or Greece.

4) Ewedemi Finance & International Studies Scholarship

This scholarship endowment was established by Dr. Soga O. Ewedemi to provide support to **a full-time Clarion University graduating senior or graduating MBA student.** Dr. Ewedemi, prior to his retirement in 2011, served the Department of Finance and College of Business Administration in several capacities. The recipient must be one of the following to be eligible:

- a) An International Student majoring in Corporate Finance who has earned at least 3.5 GPA at Clarion as a full-time student over at least two semesters
- b) A full-time Corporate Finance major, who isn't an International Student, having a minimum of 3.7 GPA
- c) An International Student with at least a 3.7 GPA; or an International MBA Student with at least a 3.8 GPA.

5) The Dr. G.M. Ghosh Memorial Scholarship

This scholarship was established by Dilip Ghosh ('78) for students **who are nationals of India** entering the University's Master of Business Administration (MBA) 11 month and/or 2-year program, or for students who are already enrolled in the MBA program at Clarion University. The scholarship will be provided to a student who is in good academic standing and has a GPA of at least 3.0. The scholarship is intended to assist with the student's successful completion of the program.

If there are no Indian-nationals in the MBA program, an Indian-national or child of an Indian-national of any major may be considered. Any international student of any major may be considered if no applicant meets the Indian-national or child of an Indian-national requirement.

6) Sitzman International Student Award

This is an annual award that is presented at the end of every Spring Semester to the outstanding international student of the year based on services and activities performed for the University, the Clarion International Association, civic and professional groups, and other activities of academic and cultural enrichment.
