IV. REPORT OF THE UNIVERSITY AUDITED FINANCIAL STATEMENTS FOR THE YEAR ENDING JUNE 30, 2021.

Ms. Vicki Raivitch, CliftonLarsonAllen, presented the University's audited financials for the prior year. The audit process was performed in accordance with generally accepted auditing standards.

V. REPORT OF STUDENT AFFAIRS

Susanne Fenske reported as of November 1 the University's health services are outsourced to UPMC. Students are happy to have the extended hours of service. Our COVID vendor testing changed hands, Clarion tied for first place for 2021 Best Action Plan in the ALL IN Campus Democracy Challenge, the RSOs are working toward more in-person meetings, and the Student Affairs leadership team for PennWest was announced.

VI. REPORT OF THE CLARION UNIVERSITY FOUNDATION, INC.

Trustee Kifer reported that the Foundation recently went through their fiscal year end. The endowment for fiscal year end was a 26.1 percent growth since 2020. They are having discussions on integration participation.

VII. REPORT OF ACADEMIC AFFAIRS

Dr. Gent shared some recent events that included the theatre production "Sugar Wife" that is showing this week, the SBDC did the finalists for the BizPitch competition, and she attended the senior honors presentations. They are sharing services with Cal's athletic training program in the cadaver lab.

VIII. REPORT OF STUDENT TRUSTEE

Kathryn Robinson, Student Trustee, reported that all student trustees from the three institutions met and discussed the transfer to the new student software system. They also talked about food service and integration concerns.

IX. REPORT OF STUDENT SENATE

Ryan Zavinski reported that Senate meets on Mondays and they invite guest speakers to attend. They also invited Cal's Senate president to sit in. Their activities this semester have included approval of new RSOs and town hall meetings for students to share concerns. They recently held a retreat in Emlenton for team building. He is serving on a subcommittee for integration and working on consistency for all three institutions. The Venango Student Senate will now have four seats on the Clarion Senate to participate in their meetings.

X. REPORT OF MULTICULTURAL STUDENT LEADERSHIP COUNCIL

Nia Latham reported that the Council consists of representatives from various multicultural organizations. They participate in workshops, host events such as Clarion's Got Talent, Hip Hop and invite guest speakers to their meetings.

XI. REPORT OF UNIVERSITY ADVANCEMENT

Jim Geiger shared Clarion fundraising figures. Alumni donors are up to 900, they are coordinating with CalU and EU on marketing campaigns, working on the division's new organizational structure and PASSHE's policy provided guidance on the PennWest diploma and student leaders will help with the new design.

XII. REPORT OF FACULTY SENATE

Dr. Jackie Knaust, Chair, reported that Faculty Senate has populated their standing committees and approved the slate, they approved curriculum and continue to work with Cal and EU to develop structure at PennWest.

XIII. REPORT OF ENROLLMENT MANAGEMENT

David Dollins reported they are planning student admit days for spring. They are working on retention efforts by helping freshman and sophomores register for spring semester. Regarding integration, his committee is working on the CRM software that will be launched in January, the application is now available for fall '22 students, they had 40 high school counselors attend their virtual visit and over 300 students and parents attended their open house.

XIV. REPORT OF THE OFFICE OF DIVERSITY, SOCIAL EQUITY, & MULTICULTURAL EDUCATION

Rogers Laugand reported that Student Senate hosted its annual Equity Awards Dinner and Ceremony Nov. 9, Building Bridges has completed their program for the semester and they hosted a Human Trafficking event co-sponsored by Representative Donna Oberlander.

XV. REPORT OF FINANCE, ADMINISTRATION AND FACILITIES

Len Cullo provided a facilities report emphasizing the demolition of Carrier hall and Thorn I & II buildings and renovations to Egbert hall. The bids are out and expect to hear from DGS this calendar year. He anticipates these projects to get started next fall.

XVI. REPORT OF THE PRESIDENT

President Pehrsson reported that Integration planning continues and our three sister institutions are coming together as one. In eight months, we will become the second largest university in Western Pennsylvania! Points of Pride included the Council for the Accreditation of Educator Preparation announced that Clarion is one of 26 providers from 17 states and the United Arab Emirates to receive recognition for leadership and commitment to continuous improvement, and on October 14 we announced the name of the integrated university – Pennsylvania Western University, or PennWest University.

XVII. REPORT OF THE BOARD OF GOVERNORS

Trustee Weaver noted that the Board of Governors met on Oct 13-14 and approved \$550 million Capital Spending Plan for integration. They approved \$73,000 to be used for DEI efforts. Funding for the Plan is determined by the Governor. The Chancellor sent a letter to Governor Wolf asking for his approval. He attended the DEI Summit last week and during the public BOG meeting they outlined the analytics dash board.

XVIII. REPORT OF PACT

Trustee Bauer reported that PACT met on October 15 with 70 trustees in attendance. They had presentations on integration and a DEI update. They discussed advocacy and support for the System as a whole regarding funding. The spring conference will be at Hershey Lodge, March 23-25, 2022.

XIX. REPORT OF COUNCIL CHAIR

Trustee Dunbar reported that she and Trustee Pickett spoke at the Inaugural Dr. Dale Presidential Leadership Academy. Penn State Extension Rural-Urban Leadership Program (RULE) held its meeting at Clarion University. She shared with the group photos from RULE.

XX. COMMITTEE REPORTS

1. RESOLUTION OF APPRECIATION

WHEREAS, Robert G. Bubb has had unassailable ties to Clarion University, beginning with his arrival at Clarion State College in the Summer of 1966 as head wrestling coach; and in 1992, after 26 seasons of developing wrestlers and men, he retired from coaching with a legacy that is envied by the wrestling world; and,

WHEREAS, Robert G. Bubb led Clarion to a 26-year slate of 322-121-4 and was only the fourth NCAA Division I coach to reach 300 career wins in 1990; and,

WHEREAS, Robert G. Bubb has been recognized for excellence by Clarion University, being inducted into the Clarion University Sports Hall of Fame in 1995 and named as a Distinguished Service Alumnus in 1997; and, WHEREAS, Robert G. Bubb's teams placed in the top 10 at the NCAA Division I Nationals four times and ranking in the top 25 a zenith total of 16 times; and,

WHEREAS, Robert G. Bubb led Clarion to win 11 PSAC titles and 1 EWL crown in his tenure; and,

BE IT RESOLVED, that the Council of Trustees of Clarion University of Pennsylvania, in recognition of the prominent and devoted commitment of Robert G. Bubb to Clarion University and his significant impact on the Clarion community as well as college wrestling on a national level, does hereby endorse the naming of the Wrestling Room in the Waldo S. Tippin Gymnasium and Natatorium as the Robert "Bob" Bubb Wrestling Room, pursuant to the Clarion University Policy on Naming of Clarion University Facilities and Program Centers; and be it further

RESOLVED, that this resolution shall be made a matter of formal record in the minutes of the Council of Trustees for November 18, 2021.
