WHEREAS, John V. Calipari has been recognized for excellence by Clarion University, being inducted into the Clarion University Sports Hall of Fame in 1995 and named as a Distinguished Service Alumni in 1997;

WHEREAS, John V. Calipari has provided leadership in the sport of college basketball, being a 2015 inductee into the Naismith Memorial Basketball Hall of Fame; guiding six teams to the Final Four, leading one to a NCAA National Championship; and induction into the Western Chapter of the Pennsylvania Sports Hall of Fame on May 2, 2009;

RESOLVED, that the Council of Trustees of Clarion University of Pennsylvania, in recognition of the prominent and devoted commitment of John V. Calipari to Clarion University and his significant impact on the Clarion community as well as college basketball on a national level, does hereby endorse the naming of the Main Court in the Waldo S. Tippin Gymnasium and Natatorium as the John V. Calipari Court, to be known as "Coach Cal Court" pursuant to the Clarion University Policy on Naming of Clarion University Facilities and Program Centers; and be it further
