The Personal Financial Planning (PFP) track is registered with the Certified Financial Planner Board of Standards Inc. and meets the educational requirement for the CFP®, CERTIFIED FINANCIAL PLANNER™ designation. The PFP track is desirable for students planning a career as a financial planner as well as careers in banking, financial investments, and insurance.

- ❖ The Financial Management Association arranges professional speakers and student competitions.
