This form (PASSHE-Clarion University) has been developed by Pennsylvania's State System of Higher Education, pursuant to Pennsylvania's Child Protective Services Law, 23 Pa.C.S. § 6301 et seq., to be used by current and prospective employees and volunteers for the written reporting of any arrest or conviction of a Reportable Offense. This form shall also be used by current and prospective employees and volunteers to provide written notice within seventy-two (72) hours after an arrest or conviction for a Reportable Offense or notice that the person has been listed as a perpetrator in the statewide database.

Individuals completing this form are required to submit the form to the administrator or other person responsible for employment decisions at the university. If you have questions regarding to whom the form should be sent, please contact your supervisor or the office of human resources at the university.

If you have any question about whether to report an offense, you should report it. Failure to report may result in disqualification for employment.
