Nomination Criteria

Nomination Process:

- Letters of nomination for the **Mary Walter CA of the Year** must be received from a minimum of two sources within the Clarion University community to be considered for the award.
- Letters of nomination for the **Dr. Marilynn Mikolusky CA Rookie of the Year** award must be received from at least one source within the Clarion University community to be considered for the award.
- These letters should be submitted to 218 Becht Hall, by 4:00 pm, Friday, March 29th, 2019.
- There will be no restriction on the number of CA’s nominated from any one staff member.
- The Residence Life staff will review submitted materials and recommend three nominees for each award to the Director of Residence Life Services, who will make a selection based upon materials submitted, and Residence Life staff recommendations.
- REMEMBER – nominees do NOT need to be aware of every nomination – it can be a surprise!!

Tips for completing nomination forms:

- Letters must be typewritten to receive consideration.
- Letters should cite *specific* examples of the nominee’s contributions to the Clarion University community, which demonstrate service “above and beyond the call of duty”.

Residence Life Staff Review Committee will consider the following:

- Nomination letters which confirm that the nominee has made a significant contribution to the Clarion University community.
- The nominee must be employed as a Community Assistant at the time of nomination and have been employed as a CA for less than two semesters for the “Dr. Marilynn Mikolusky CA Rookie of the Year” Award, and in their third semester or beyond for “Mary Walter CA of the Year” Award.
- The nominee must possess a minimum grade point average of 2.5.
- The nominee exceeds programming requirements in both quality and number of programs in the residence hall.
- The nominee demonstrates satisfactory performance both academically and para-professionally.
