how to apply for FINANCIAL AID

File your FAFSA. The Free Application for Federal Student Aid (FAFSA) is available at **STUDENTAID.GOV**. For priority consideration, submit your FAFSA before March 1 using Clarion's school code: 003318.

> Federal and state governments are the primary sources of financial aid. Students apply for federal and state aid by filing the FAFSA.

The student and at least one parent (unless you are an independent student) must have an FSA (Federal Student Aid) ID to electronically sign and file a FAFSA. You can file your 2022-2023 FAFSA as early as Oct. 1, 2021.

filing your FAFSA

Deadline

The deadline to apply for Pennsylvania state grant aid is always May 1. The application for the Pennsylvania state grant is the FAFSA; however, vou must also complete PHEAA's state grant form at WWW.PHEAA.ORG.

When Will I Hear?

Typically you will be informed of your expected family contribution (EFC) immediately upon completion of your FAFSA. Students have the opportunity to review their previously submitted FAFSA data via the electronic Student Aid Report (SAR) approximately 48 hours after submitting their FAFSA.

Pennsylvania residents also receive a Grant Status Notice online from PHEAA, the Pennsylvania State Grant Agency. Once the notice is completed and electronically signed, students are notified of their state grant eligibility starting late November.

Clarion begins notifying students of their early estimated financial aid offer in January. Notifications are sent out electronically to the email you submit on your Clarion University application. 7

ways to pay FOR COLLEGE

SCHOLARSHIPS

Clarion automatically considers students for merit scholarships upon applying to the university. By offering additional support through scholarships, we can help you financially access a quality education. Additionally, athletic and endowed scholarships are available for students. We encourage students to explore external and local scholarships available through your school district.

The Clarion University scholarship application is available to incoming admitted freshmen and transfer students Jan. 1-March 1. All students receiving scholarships from the university are encouraged to complete a Free Application for Federal Student Aid (FAFSA).

GRANTS

Grants are awarded based on information from your FAFSA.

PELL Grant:

A need-based federal grant ranging from \$672-\$6,495.

PA State Grant:

A need-based grant, for Pennsylvania residents only, that ranges from \$532-\$4,254.

SEOG Grant:

A \$400 federal grant for those with maximum financial need.

LOANS

Federal Direct Loans provide lowinterest loans to students regardless of income or financial need with a fixed interest rate. Most students qualify for a portion of their loan to be subsidized, meaning that there is no interest on the loan while the student is in college at least half-time. To apply, incoming students must complete entrance counseling and a Master Promissory Note (MPN) which is available at **STUDENTAID.GOV**.

Federal Parent PLUS Loans

Parents of dependent students may borrow for their child's education through the Federal Direct Plus Loan for undergraduate students at **STUDENTAID.GOV**. The entire cost of attendance may be borrowed, minus other aid received. PLUS loans are not based on financial need and have a fixed interest rate that won't exceed 10.5%. Payments may be deferred until after graduation. If a parent is denied a PLUS loan, students may borrow additional unsubsidized Federal Direct Loan money as an independent student.

Private Loans

In addition to federal loans, a number of banks offer private loans to students. A private loan comparison tool can be

FEDERAL AND STATE VERIFICATION

Both federal and state financial aid agencies verify a percentage of FAFSA applicants. If selected for verification, you will be notified and asked to supply certain financial records. Verification must be completed in order to receive federal and/or state aid.

housing AND MEALS

Housing is on a first-come, first served basis in campus suites (Freshmen Focused Housing) and Reinhard Villages (Upper-Classmen Focused Housing). The housing application opens in November and housing choices are guaranteed through June 1.

Clarion offers six dining facilities on campus with a wide selection of meal choices from all-you-can-eat to grab-and-go sandwiches, sushi at Carlson Cafe to world-famous coffee at Starbucks. Clarion's meal plans provide great options that afford a pleasant break from your daily scholastic routine.
